- And circulate Petitions for School Board P-7 (make as many copies as needed)
- Statement of Economic Interest

Submit your completed application, including:

- Statement of Candidacy
- Loyalty Oath (optional)
- Statement of Economic Interest
- Petitions with the required number of signatures (Minimum of 50, except for North Wamac which is 33).

Submit your complete application package to the County Clerk of the county in which the school building is physically located. Note this may be different than your county of residence. Candidate applications are no longer accepted at the schools.
