

## NOTICE TO CLINTON COUNTY TAXPAYERS: ASSESSED VALUES FOR 2022

Publication is hereby made for equalized assessed valuations for real property in this County in accordance with 35 ILCS 200/12-10. As required by 35 ILCS 200/9-210 and 35 ILCS 200/10-115, the following equalization factors have been applied to bring the assessments to the statutorily required three year median level of 33.33%: Township multiplier for Brookside Township is as follows:

Pursuant to 35 ILCS 200/10-115, the Farm Land assessments for the 2022 assessment year will increase by 10% of the preceding year's median cropped soil productivity index as certified by the Illinois Department of Revenue with data provided by the Farmland Assessment Technical Advisory Board resulting in a \$38.73 per acre increase for each soil productivity index.

Property in this County, other than farmland and coal, is to be assessed at a 33.33% median level assessment, based on the fair cash value of the property. You may check the accuracy of your assessment by dividing your assessment by the median level of assessment. The resulting value should equal the estimated fair cash value of your property. If the resulting value is greater than the estimated fair cash value of your property, you may be over-assessed. If the resulting value is less than the fair cash value of your property, you may be under-assessed.

**ANYONE WHO CONSIDERS THEIR ASSESSMENT TO BE INCORRECT MAY FILE AN APPEAL IN WRITING WITH THE CLINTON COUNTY BOARD OF REVIEW. FILING DEADLINE IS **December 9, 2022**. All written appeals must be filed on form PTAX-230 or PTAX-227 for farmland and will be acted upon in accordance with the law.**

**PROCEDURE TO FILE AN APPEAL: Complete an appeal form PTAX 230 or PTAX 227 for farmland, available at the Office of the Chief County Assessing Officer or County website: [clintonco.illinois.gov](http://clintonco.illinois.gov). Evidence to support your appeal **MUST** be submitted with the appeal at the time of filing. Evidence required may be in the form of an appraisal, recent sale or construction data or comparable sales data sheet.**

The amount of your tax bill is determined by taking the equalized assessed value (after board of review and state equalization) of your property and applying the aggregate tax rates from the levies of all local taxing districts and units of local government in which your property is located. Your property tax bill is calculated as follows:

$$\textit{Final Equalized Assessed Value} - \textit{Exemptions} = \textit{Taxable Assessment}$$

$$\textit{Taxable Assessment} \times \textit{Current Tax Rate} = \textit{Total Tax Bill}$$

**You may qualify for a 4 year homestead improvement exemption if an increase in assessment is due to an improvement to your homestead property. Other exemptions to reduce your property's equalized assessed value are: general homestead, disabled persons, disabled veterans, returning veterans, and senior citizens. For information and application, contact the chief county assessment office at 618-594-6610.**

All of the following assessed values by the chief county assessment officer are subject to further equalization and revision by the Clinton County Board of Review as well as state equalization by the Illinois Department of Revenue.
