### EXEMPTION CERTIFICATE FOR BUILDING MATERIALS

#### What is eligible for a Building Materials Sales Tax Exemption Certificate?

- Building materials to be incorporated into real estate in an Enterprise Zone by rehabilitation, remodeling, or new construction.
- Must be for commercial, manufacturing, or industrial construction and not for residential.

#### How do I apply for a Building Materials Sales Tax Exemption Certificate?

- Property owners must apply through the Clinton County Enterprise Zone Administrator. Complete this form and return by email or fax. Contact information is listed above.
- Zone Administrator will submit applications for property owners, construction contractors, and subcontractors purchasing materials to incorporate into real estate in the Enterprise Zone.
- The project for which an exemption is sought must meet the eligibility requirements set forth in the Clinton County Enterprise Zone ordinance.
- All applicants must submit end-of-year reports through the “Business Incentives Reporting and Building Materials Exemption Certification” link at the Illinois Department of Revenue’s website at [tax.illinois.gov/Businesses/Incentives/](http://tax.illinois.gov/Businesses/Incentives/).
